## Pool Season

It will not be long before that warm sunshine we all have been waiting for will be here, and that means pool season will follow. So, before we start planning swimming in our back yard there are some state requirements for outdoor residential swimming pools that we all need to be aware of to keep our family, neighbors, and friends safe this season. The Virginia Uniform Statewide Building Code requires a building permit for any swimming pool that is larger than 150 square feet in surface area, holds over 5,000 gallons of water or is 24 inches or more in depth. The code makes no distinction between in-ground, above ground or inflatable pools, hot tubs, or spas. To help you answer these questions: What is the process? What documents do I need? What permits do I need? Who should apply for the permits? What are the fees for the permit? How long does it take to get the permit? Outdoor swimming pools are required to have barriers around them! What type of barriers? What are the entrapment protection requirements? What are the electrical requirements? And what are the inspection requirements?

The Town of Wytheville Building Department has an online pamphlet that is your guide to the permit and inspection process and lists the requirements for installing outdoor residential swimming pools. Please use the following link to access the information or call (276) 223-3339 or 3354.

## Upcoming Events

- **Relay for Life:** May 21, 2022, from 6:00—9:00 p.m. at Elizabeth Brown Park. Bring a lounge chair.
- **Run For The Wall:** The much-anticipated return of Run For The Wall (RFTW) occurs on May 25 and 26 in Withers Park. The "Welcome Home Ceremony" will begin upon their approximate arrival at 4:30 p.m. on Wednesday, May 25, in Withers Park. Citizens are encouraged to come out and welcome them as the group arrives via Exit 70 and Fourth Street. Following a brief ceremony, the group will parade down Main Street to their hotels. A dinner hosted by the Wytheville Moose Lodge will conclude the evening. One of RFTW's favorite Wytheville experiences occurs on Thursday (May 26) morning as the students of Spiller Elementary School provide a special welcome program beginning at 9 a.m. in Withers Park. Run For The Wall will depart with a Main Street parade at approximately 9:30 a.m.

## Important Information from Your Fire & Rescue Department

The Town of Wytheville Fire & Rescue Department is a 24 hour, 365-day staffed fire and rescue service available to the citizens it serves. In the event of an emergency, whether a fire or a medical call, DO NOT HESITATE or delay accessing 911. In the event of an emergency, seconds and minutes count greatly. The sooner 911 is accessed, the quicker we are available to be part of the solution.

Also, the Town of Wytheville Fire & Rescue Department is launching a "BE SEEN" campaign. Participants would purchase a reflective marker from the store of their choice and place it in front of their home. This could improve response times and help responding units when a call for service is needed. Yes, we memorize streets and driving routes, but this simple visual can help responding personnel, specifically at night. Many can be attached to mailboxes, but also can be placed close to the street in the front yard. Even if you live outside the town, but are in our coverage area, we highly recommend this.



## Important Information from Your Police Department

"IF YOU SEE SOMETHING, SAY SOMETHING" - There seems to be almost daily occurrences of people posting things on social media about what they have seen or encountered, and then there are others posting a negative reply against the Town and the Police Department for not responding or doing anything about it. If that person would have simply called 911 when it was happening, instead of posting on social media hours after the occurrence, the Police Department would have had the opportunity to respond and resolve the situation.



If a citizen observes something that is just not right, they should call 911 immediately. A suspicious activity report is the sharing of information concerning activities, incidents, or behaviors that the reporting individual considers to be outside normal parameters. This can include, but is not limited to, threats, risks, or concerns to the public safety and is not limited to known criminal activities. Here's some examples: Someone being inappropriate in public parks, parking lots, or stores. Someone in a parking lot going from vehicle to vehicle checking for unlocked vehicles. Someone coming to your door asking if someone lives there that does not. Someone going house to house checking for locked doors. When you are making a report, you should try to provide this information: WHO did you see? WHAT did you see? WHEN did you see it? WHERE did you see it? WHY is it suspicious? But remember factors such as race, ethnicity, gender and or religious affiliation are not indicators of suspicious behavior.

When and how to notify the Police: If you believe you have information that would help authorities, you are encouraged to do the following, call 911 immediately for life-threatening emergencies and crimes in progress. For reporting something after the fact or an ongoing issue, call local law enforcement on a non-emergency number or via email.
