Sealed BIDS will be received by the Town of Wytheville at the Engineering Department in the Municipal Building, Wytheville, Virginia, until July 18, 2019, at 2:00 PM., local prevailing time and thereby publicly opened and read aloud.

Sealed Bids shall be delivered to the Engineering Department, Town of Wytheville, 150 E. Monroe Street, P.O. Box 533, Wytheville, VA 24382, ATTN: Trevor Hackler, Town Engineer, in a sealed envelope marked "Town of Wytheville Paving and Milling Project 2019" with Contractor's name, address and registration number on the outside of the envelope. When obtaining the Contract Documents, the Bidder shall designate a representative who will be responsible for all correspondence between the Town and Bidder and shall include his/her name, title, address, phone number, fax number and email address.

PROJECT

The project consists of milling approximately 10,101 yd²-inches (square yard per inch of depth) of existing pavement along portions of various streets as indicated within the specifications and applying approximately 6,147.1 tons of non-polishing aggregate bituminous concrete paving as indicated in the specifications and on the accompanying map.

BIDS

Each bid must be accompanied by a certified check or acceptable Bidder's Bond in the amount of five percent (5%) of the total bid made payable to the Town of Wytheville. The successful Bidder will be required to furnish Performance and Payment Bonds with sureties authorized to do business in the State of Virginia, for the full value of the Contract. Each Bidder submitting a proposal must be registered as a "Class A" Contractor in the Commonwealth of Virginia in accordance with Title 54.1-1112, Code of Virginia 1950.

WITHDRAWAL OF BIDS

The procedure for withdrawal of BIDS shall be according to Section 2.2-4330.A(i) of the Code of Virginia.
